



## Terms & Conditions

**TREX** only wholesales to legitimate golf cart and powersports businesses with a physical retail location (licensed place of business open to the public during normal business hours). Exceptions may be made for certain drop-shippers. We do not engage in retail sales and we reserve the right to refuse any dealer application. What **TREX** requires from dealer applicants

**Freight:** **TREX** pays freight on orders over \$2,500 delivering to the continental 48 states. Freight must be Prepaid or Freight Collect on shipments to Alaska, Hawaii, Puerto Rico and other countries. For orders less than \$2,500, a shipping charge will be added. **TREX** makes an effort to same day ship orders placed before 2:00p Eastern Time. **TREX** is unable to accommodate edits and changes to billed orders - a new order must be placed.

**Limited Warranty:** **TREX** Golf Cart Accessories warranties all new products against manufacturer defects for one year from customer purchase date. **TREX** Golf Cart Accessories and its parent company are not liable for service calls, alleged harm, or damaged material resulting from the installation of **TREX** products.

**Merchandise Returns:** **TREX** dealers must receive an RMA (Return Merchandise Authorization) prior to returning merchandise. RMAs may be requested via [www.trexfordcart.com](http://www.trexfordcart.com) or by contacting an account manager. A **TREX** Return Form must accompany all returns. Freight is the responsibility of the dealer on all returns, warranty or otherwise. RMA numbers are valid for 45 days from issue date. There is a 20% restocking fee for non-warranty returns that are returned over 45 days from purchase date. Only products that are currently stocked are eligible for return. All returns should be in the original packaging. Items returned without an RMA number are subject to refusal or a 20% restocking fee.

**Merchandise Claims:** **TREX** must be notified within 2 days of delivery date (with notation on Bill of Lading) if delivered merchandise does not match invoice, is defective, or comes damaged to ensure that merchandise may be considered for credit/refund.

**Backorders:** All backorders ship automatically when backordered products become available. **TREX** confirms backorders older than 30 days with customers before shipping merchandise.

**Catalog Contents:** **TREX** attempts to accurately represent content, prices, and specifications in our product catalog. **TREX** reserves the right to change prices and/or terms and conditions without notice. **TREX** assumes no liability for errors in listings, specifications, product descriptions, pricing, or applications.

**Yearly Requirements:** **TREX** reserves the right to pause/revoke dealer accounts that do not meet a minimum yearly purchase requirement of \$5,000.
